### Resolution 09-08 B-24 - MASTER AGREEMENT WITH THE FARMWORKER INSTITUTE FOR EDUCATION & LEADERSHIP DEVELOPMENT

BE IT RESOLVED that the Palo Verde Community College District Board of Trustees approves the Master Agreement between PVCCD and the Farmworker Institute for Education & Leadership Development (FIELD), as shown in Reference B-24, to offer non-credit ESL and basic skills courses as outlined in agreement. The District will pay FIELD \$4.11 per non-credit student contact hour eligible for state general apportionment (not to exceed \$999,999 per year) and will bill FIELD for student enrollment fees. This three-year agreement shall commence on May 12, 2009, and be reviewed annually by February 28<sup>th</sup> of each year.
