## COLLEGE RESPONSE TO COMMISSION RECOMMENDATION 2

In its action letter dated January 29, 2010, the Commission asked that a Follow-Up report be submitted by October 15, 2010 addressing the Commission Recommendation 2. Please note that Palo Verde College staff requested an extension of time to November 17, 2010 to submit the report.

### Commission Recommendation:

Commission Recommendation 2: The College should provide evidence that faculty and others directly responsible for student progress toward achieving stated student learning outcomes have, as a component of their evaluation, effectiveness in producing those learning objectives (III, A. 1.c.).

### Palo Verde College Response:

The College recognizes that matters pertaining to faculty evaluations are part of the collective bargaining process. This point was addressed in the College's Follow-Up Report dated October 15, 2008.

Furthermore, in its Follow-Up Report dated October 15, 2009, the College indicated that the chair, or representative, of the Student Learning Outcomes Committee, a committee of the Academic Senate, would "review with the CTA Executive Board and other College officials more specific approaches that would be acceptable to all parties and that would satisfy the recommendation."

The result of these efforts is that during the 2010-2011 Academic Year, the inclusion of student learning outcomes assessment in faculty evaluations will be among the topics considered in collective bargaining between the Palo Verde College Association CTA/NEA and the Palo Verde Community College District Board of Trustees.
